Mr W Pernice thanked the members of the Complaint's Panel who have given up their time to ensure that the association doesn't need to pay fees to solicitors regarding outstanding complaints within clubs and zones and once again asked that clubs and zones use a proactive approach to complaint handling so that complaints are dealt with as soon as possible.

RAS

Mrs J Frankum reported on the telephone meeting held with the RAS where several items were discussed as below:

- RAS entries to open on the 15 December 2018
- RAS closing date to PCA NSW 11 January 2019
- Pony Club parade will be held at 1pm on Pony Club day, this is to ensure better representation of riders attending
- That riders wishing to nominate for the Pairs and Team of Fours must also nominate for individual rider classes to ensure that all rider details are captured in the RAS system
- Forms have been updated and will be circulated, all nominations and payment for rider classes
 to come from the Zone, one cheque for all. Forms must be completed correctly or will be
 returned MUST include rider and horse details including microchip number and horse must be
 registered with the Australian Animal Register (AAR).
- Riders will not be able to bump in prior to 1pm Monday 23 April it was suggested that any
 riders traveling distances contact clubs/zones nearby to organise camping prior to this date if
 needed.

- All team managers will require a current Working with Children Check registration which will be verified, details on new forms.
- Loft allocations limited to three (3) riders and/or team managers only and will not be allocated if the rider does not indicate on their form that they require loft accommodation. Parents will not be able to stay in lofts unless they are the Team Manager.
- Stable allocations and invoices will come directly from the RAS based on the information provided on forms.

Mrs J Frankum said that due to the difficulty of getting enough riders for Area Sporting Teams she suggested that teams be changed to Zone Sporting Teams.

2019 Nationals Championships – Ms J Morgan said that preparations were well underway for the 2019 Nationals Championships with the Sub-committee meeting to discuss the program, draw, official dinner

etc. Ms J Morgan said that details of Training weekends would be circulated by the office shortly along with Long List application forms for riders to complete.

Ms J Morgan said that once again Pony Club Australia would be hosting the International Showjumping competition and as such NSW would need to supply approximately 15-20 B grade standard horses for the pool of horses needed for this event for 3-4 days. Expressions of Interest will be circulated to members, outlining the horses required, what (if any) costs will be met by Pony Club Australia and the responsibility of the owner and riders who borrow the horses during the Nationals as soon as possible.

Discussion held that the proposed change seemed suitable but would need to either be circulated to Zones for discussion or come as an Executive Recommendation. Members present requested that the Executive adjourned to discuss submitting an Executive Recommendation.

a) Work Health and Safety – Mrs K Britton said that this topic would continue to be an agenda item to ensure that the Association remains compliant however at this stage clubs are compliant with the Code of Practice. Clubs and Zones needed to be mindful of their responsibility to volunteers and ensure that they are looked after including providing shelter, catering etc. plus making sure that volunteers are not involved in activities that they are not physically capable of to ensure theirs and riders safety.

If you have any concerns regarding an activity, please contact the office to seek clarification from the brokers. In most cases the activity will be covered under pony clubs core business however the sub-leasing of grounds, private or otherwise has recently come under scrutiny after an accident involving a third-party hire of the grounds and an injury.

b) Working with Children Checks - Mrs K Britton said that information regarding the changes to the WWCC Act have been circulated to clubs, noting that pony club's recommendation that all volunteers attending overnight camps was ahead of the changes to the Act so already compliant. Reminder to finalise the process by verifying any WWCC registration numbers received and always following child safe practices at all times.
