The Australian Sports Foundation Ltd. Pursuant to the ASF's listing in the Income Tax Assessment Act (1997) (div 30, S 30-90), donations of \$2 or more to the ASF are tax deductible.

Donors must contribute unconditionally to the ASF to claim a tax deduction, however the ASF's structure makes it possible for a donor to nominate a registered project as the preferred beneficiary of their gift. The Pony Club Association of NSW Incorporated - PCANSW Sports Development Fund, project no. 213165, is registered with and conducted under the charter of the ASF. - National Championships: Financial assistance for NSW riders to attend the biannual National competition in the Olympic disciplines of dressage, show jumping, eventing and mounted games.
