ABOUT THE AWARD

Incepted in 2010 courtesy of a NSW Sport and Recreation Grant, the Volunteer of the Year award is a means of saying thank you for their hard work and commitment whilst aiming to encourage more members to volunteer their time.

ELIGIBLE NOMINEES

To be eligible for considerations nominees must meet the following criteria: -

- Aged 13 years or over
- Current financial member
- Volunteered for their Club and/or Zone a minimum of 50 hours over a 12 month period
- Nomination must be submitted on the official form

ASSESSMENT PROCESS

An initial eligibility assessment will be undertaken to determine that the nominee has met the criteria and that the Nomination Form has been completed correctly and in full. Next, an assessment panel with representatives from the State Office and Executive Committee will assess all eligible nominations. Nominations will be assessed on merit and scored against the following criteria:

1. Nominee demonstrates the attributes of a good volunteer
2. Nominee provided practical assistance and contributed to the positive growth and development of the Club and/or Zone

One nominee per zone is selected. In the event that a suitable nominee is not presented within a zone, all unsuccessful nominees will be reassessed and a nominee selected. Maximum number of awards presented per year is 28.

HOW TO NOMINATE

A member may nominate themselves or be nominated by a current financial member. A completed Nomination Form must be sent to the state office by 24 June 2019 via:
